To ensure a completely safe environment for our guests,

people will not be allowed to board if they:

- Require mechanical ventilation support (excluding CPAP for sleep apnea)
- Require the use of additional oxygen cylinders (those who bring and use their own oxygen concentrators are allowed to board)
- Require hemodialysis (peritoneal dialysis is allowed)
- May pose a risk to the health and safety of others (any medical condition that if left unchecked is a risk to the patient and a potential
- risk to other guests and crew members)
- Suffer from three or more of the following diseases, regardless of age:
 - Ischemic heart disease, atrial fibrillation, heart failure, high blood pressure, type 2 diabetes, chronic lung disease, chronic liver disease, chronic kidney disease/dialysis, autoimmune diseases, obesity, cancer undergoing treatment. Those with these conditions should consult their doctor before booking a cruise.

• They have been instructed to isolate or quarantine themselves (guests

• They have experienced symptoms of acute gastroenteritis (AGE) in the 5 days prior to boarding
